Community Development Director Matt Glaesman introduced item. Applicants proposing reinvestment of residential structure to residence to east of property for use as prep/storage for Val's Diner. Planning Commission recommends approval. Super majority vote required. It was moved by Councilmember Masters, seconded by Councilmember Conway to approve. No discussion. Motion unanimously passed. Ordinance adopted and assigned 2816.

## 20. RESOLUTION AMENDING PLANNED UNIT DEVELOPMENT (PUD) 23 TO ALLOW TWO ADDITIONAL APARTMENTS IN THE BUILDING LOCATED AT 1615 15<sup>TH</sup> AVENUE SOUTHEAST (DPA-2020-02)

ACTION TAKEN: MASTERS/CONWAY/APPROVED 7-0 RESOLUTION ADOPTED AND ASSIGNED 2020-07-68

Public Hearing was opened and closed at 3:15pm prior to the meeting. No public testimony was received.

Community Development Director Matt Glaesman introduced item. PUD does establish maximum number of units. Addition of units does trigger resolution. Concern on parking regarding addition of new units. Planning Commission recommended

approval contingent on adding four new off-street parking spaces PUD confirmed addition of new parking.

It was moved by Councilmember Masters, seconded by Councilmember Lewis to approve. Councilmember Lewis requested clarification of where apartments will be located. Glaesman commented that apartments will be added to common area at SE portion of site. Councilmember Hontos requested confirmation on additional parking spaces and winter parking. Glaesman commented that this has been communicated to property owners regarding snow removal. Required off-street parking may not be used for storage and a violation of Land Development Code. Councilmember Conway inquired on if a time table has been established for the new parking spaces. Glaesman commented that confirmation of spaces are needed prior to certificate of occupancy issued. City was encouraging PUD to internalize parking rather than removing green space between building and homes. No further discussion. Motion unanimously passed. Resolution adopted and assigned 2020-07-68.

### 21. RESOLUTION TO EXTEND THE MAYOR'S LOCAL EMERGENCY DECLARATION

ACTION TAKEN: MASTERS/CONWAY/APPROVED 7-0 RESOLUTION ADOPTED AND ASSIGNED 2020-07-69

Mayor Kleis commented that this simply extends the existing emergency declaration. May be rescinded at anytime by Council action or State Emergency declaration rescinded. Councilmember Conway thanked Mayor Kleis for his leadership. No further discussion. Motion unanimously passed. Resolution adopted and assigned 2020-07-69.

### **OPEN DISCUSSION AND ANNOUNCEMENTS:**

Councilmember Hontos commented on COVID-19 and mandating masks via City Ordinance. Moved to include as an agenda item for July 27, 2020 meeting. Councilmember Lewis seconded the motion. Motion passed 5-2 with Councilmembers Brandmire and Conway opposed.

Councilmember Lewis commented on Fireworks and changing ordinance to be comparable to noise ordinance, ending fireworks at 10:00pm rather than midnight. Motion passed 5-2 with Councilmembers Brandmire and Conway opposed.
