Public Hearings:

19. **APPLICATION FOR AN-SALE INTOXICATING AND SPECIAL SUNDAY LIQUOR LICENSES FOR XENIA, LLC DBA BROTHERS BAR & GRILL, EST. 1967 FOR AN ESTABLISHMENT TO BE LOCATED AT 119 SOUTH 5TH AVENUE.** Gregg Engdahl, City Clerk, presented the application. Council President Libert opened the public hearing. No one testified. Council President Libert closed the public hearing. Joshua Aliesch addressed the Council and answered general questions related to the business. He also noted that there approximate opening date is beginning of May. Goerger/Gohman moved approval. Motion carried unanimously.
20. **APPLICATION FOR A 3.2 PERCENT MALT LIQUOR AND WINE LICENSE FOR IDELIA DEBOER DBA RIO GRILL, 266 33RD AVE. SOUTH #8, ST. CLOUD, MN 56301.** Gregg Engdahl, City Clerk, presented the application. Council President Libert opened the public hearing. No one testified. Council President Libert closed the public hearing. Masters/Goerger moved approval. Motion carried unanimously.
21. **AN ORDINANCE AMENDING THE 2007 CODE OF ORDINANCES BY ADDING A NEW SECTION 275 TO ESTABLISH THE TRANSPORTATION INFRASTRUCTURE ADVISORY BOARD.** Mayor Dave Kleis gave an overview of the Ordinance. Council President Libert opened the public hearing. No one testified. Council President Libert closed the public hearing. There was discussion among the council members in regard to re-evaluation of the board and/or sunseting the board after certain time had passed. Johnson/Masters moved to sunset the board after three years. Motion failed 1-5: Councilmember Masters voted in favor. The remaining council members felt it should be shorter than three years. Hontos/Johnson moved to have the board sunset after two years. Motion carried unanimously. Ordinance was assigned number 2523.

Open Discussion:

- Councilmember Hontos brought forward discussion on local bar establishments and how their actions are being monitored. He mentioned having an unofficial agreement with the Hospitality Association that they will monitor to make sure that bars are following certain procedures, such as not having drink specials. Mayor Kleis stated that the City enforces the ordinances that have been adopted relating to liquor establishments. In addition, the Administration will continue to have dialogue with the Hospitality Association in regard to local establishments.
- Mayor Kleis expressed his gratitude to those who helped with distributing the community survey.
