

Section 580 – Parking Fees

Section 580:00. Parking Fees.

Subd. 1. Parking Meter Hoods. \$15.00 day per parking space utilized.

Subd. 2. 15-Minute Meter Installation. \$200.00 per meter installation.

Subd. 3. Parking Permit Fees – Quarterly Payments plus all applicable Sales Taxes:

Subd. 5. Loading Zone Fees - Annual Payments:

\$800.00 per stall per year within parking meter zone \$24.00 for each supplemental “customer parking” sign or similar message sign within the parking meter zone.

\$45.00 per year per 24-foot parking stall or fraction thereof outside of parking meter zone.

\$55.00 per year per valet loading zone plus the cost of any signs to be installed by the City.

Subd. 6. Parking Meter Zone Fees.

All on-street meters (except 15-minute meters) will be \$1.00 per hour with a 2 or 4 hour maximum.

All 15-minute meters will be 50 cents per 15 minutes. Parking lot meter rates will be as follows:

• Plaza Lot	1 hour meters	\$1.00 per hour
• Convention Center Surface Lot	10 hour meters	\$1.00 per hour
• Mississippi Lot	2 hour meters	\$1.00 per hour
• River Boat Lot	2 hour meters	\$1.00 per hour
• Lady Slipper Lot	2 hour meters	\$1.00 per hour
• Canoe Lot	4 hour meters	\$1.00 per hour
• Judicial Lot	4 hour meters	\$1.00 per hour
• Railway Lot	4 hour meters	\$1.00 per hour
• River's Edge Lot	4 hour meters	\$1.00 per hour
• Cloverleaf Lot	10 hour meters	\$1.00 per hour
• Swan Lot	10 hour multi-space meters	\$1.00 per hour

Subd. 7. Parking Ramps – Event Parking. An entry fee of \$7.00 will be charged for event parking at the East River's Edge, West River's Edge, Centre Square, Paramount and Grand Central Parking Ramps. An entry fee of \$5.00 may be implemented at municipal parking facilities as determined by the Public Services Director or their designee.

Subd. 8. Parking Ramps – Non-Event Parking.

- Centre Square Parking Ramp – \$1.00 per 1 hour or fraction thereof.
- Paramount Ramp – \$1.00 per 1 hour or fraction thereof.
- Grand Central Ramp – \$1.00 per 1 hour or fraction thereof.
- West River's Edge Ramp – \$1.00 per 1 hour or fraction thereof.
- Pre-Programmed Paramount Ramp Access Card – 55 cents per hour.
- Maximum Daily Charge: The maximum daily charge (MDC) for parking in ramps shall be \$10.00. Parking patrons who lose their parking ticket shall be charged at the MDC rate. The MDC shall not apply during Event Parking or other parking operations when an entry fee is charged.

Subd. 9. Permit Lot Locations.

Subd. 10. Resident Parking Permits – Annual Payment plus all applicable Sales Taxes. All resident parking permits will be \$13.16 per permit issued per year commencing on August 1<sup>st</sup> and running through July 31<sup>st</sup>.

Subd. 11. SCSU Area Parking District – Annual Payments plus all applicable Sales Taxes. Parking permits within the St. Cloud State University Parking District will be valid for the period of time commencing on July 1<sup>st</sup> and running through June 30<sup>th</sup> of the following year. Permit fees for parking within the SCSU Parking District will be as follows:

“G” Permit \$362.66

Subd. 12. Traffic Parking Violations.

Expired Meter	\$10.00 per violation for up to five violations. \$15.00 per violation thereafter.
Improper Position	\$10.00 per violation for up to five violations. \$15.00 per violation thereafter.
Fire Hydrant	\$25.00.

Handicapped \$200.00.

All Other Parking Violations \$20.00.

Subd. 13. Late Fee Penalties. A \$5.00 penalty in addition to the initial fee will be assessed to all parking violations which remain unpaid after seven calendar days.

Subd. 14. 24-Hour Ramp Parking. Parking for over 24 hours straight in any municipal parking ramp is prohibited unless prior written approval has been granted from the Public Services Director or their designee. Vehicles parked for over 24 hours in the same facility will be towed at the vehicle owner's expense.

Subd. 15. Chaser Ticket Fees. Validated tickets (chaser tickets) are available for purchase in increments of 1 hour, 2 hours, 4 hours, 8 hours and 10 hours. Ticket fees are set at \$1.25 for each incremental hour.
